- N. Umpqua Hydroelectric Relicensing Settlement Agreement Implementation, Oregon: Provided conflict prevention and resolution to multi-party teams implementing protection, mitigation and enhancement projects.
- Lewis River Hydroelectric Relicensing, Washington: Co-mediated a settlement agreement signed by 26 competing interest groups, including two utilities, two Tribal Governments, and many local, State, Federal, community and environmental negotiators related to the operation of four hydropower projects.
- Oregon Blue Mountains Forest Plan Revision: Facilitated competing stakeholders work to collectively define issues and options for a revised, updated forest plan.
- Conflict Resolution Training: Taught classes for community, tribal, and government students at the University of Washington and Seattle University, and as needed for participants during case work.
